



**Assumption of the Risk, Waiver of Liability,
and Representations Relating to Coronavirus/COVID-19**

Camp Ajawah has put in place numerous measures and enhanced cleaning protocols to reduce the likelihood of spreading COVID-19 at Camp Ajawah. However, Camp Ajawah cannot guarantee that I or my child will not become infected with COVID-19.

Further, attending a Camp Ajawah summer camp session could increase my child's risk of contracting COVID-19. By signing the agreement, I acknowledge the contagious nature of COVID-19 and voluntarily agree to the participation terms established for the 2021 session.

I assume the risk that my child, myself, and other family members may be exposed to or infected by COVID-19 by attending any camps and activities at Camp Ajawah, and that such exposure or infection may result in personal injury, illness, quarantine requirements, permanent disability or death.

I understand that the risk of becoming exposed to or infected by COVID-19 at Camp Ajawah may result from actions, omissions, or claimed wrongdoing of myself, my child or others, including, but not limited to, Camp Ajawah employees, volunteers, other campers and their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injuries to my child, myself, and other family members (including, but not limited to, personal injury, disability or death), illnesses, quarantine requirements, damages, losses, claims, liability, costs or expenses, of any kind (collectively, "Claims"), that I, my child and our family may experience or incur in connection with my child's attendance at Camp Ajawah summer camps and programs. While Camp Ajawah has put in place numerous measures and enhanced cleaning protocols to reduce the likelihood of spreading COVID-19 at Camp Ajawah, I understand that Camp Ajawah cannot guarantee either that such measures and enhanced cleaning protocols will be followed at all times, or that such measures and enhanced cleaning protocols, even when followed, will necessarily protect against the COVID-19 disease. COVID-19 can be contracted with or without such measures, and I am not relying on any particular measures or enhanced cleaning protocols in signing this assumption of risk and waiver.

I agree to check the CDC Symptoms list (<https://www.cdc.gov/coronavirus/2019-ncov/symptoms-testing/symptoms.html>) prior to utilizing the facilities, services, and programs of Camp Ajawah. I agree, represent, and warrant that neither the undersigned nor participating children shall visit or utilize the facilities, services, and programs of Camp Ajawah if he or she (i) experiences symptoms of COVID-19, including, without limitation, fever, cough or shortness of breath, or (ii) has a suspected or diagnosed/confirmed case of COVID-19; or (iii) is subject to quarantine based upon exposure to another close contact having a suspected or diagnosed/confirmed case of COVID-19. I agree to notify Camp Ajawah immediately if he or she believes that any of the foregoing access/use restrictions may apply or come to apply.

I, on behalf of myself and participating children agree to follow all guidelines, protocols and instructions of the Camp Ajawah personnel relating to COVID-19 and the protocols for mitigating exposure.

On my behalf, and on behalf of my child, I hereby release, covenant not to sue, discharge, and hold harmless Camp Ajawah, its employees, volunteers, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto.

I understand and agree that this release includes any Claims based on the actions, omissions or claimed wrongdoing of Camp Ajawah, its employees, volunteers, agents, and representatives, whether a COVID19 infection occurs before, during or after participation in a Camp Ajawah summer camp program, to the fullest extent permitted by Minnesota law.
